A homeowner may receive a federal tax credit of 10% of material costs up to \$500 for the addition of GreenFiber natural fiber insulation to their home. This tax credit applies to qualified energy efficient products purchased and installed between January 1, 2015 and December 31, 2015. This credit is applicable for the 2015 tax year.

**Lifetime Limitation:** The lifetime limitation on the tax credit reverts to \$500 total for the years in which the tax credit has been available since 2006. If a taxpayer claimed a 25c tax credit of at least \$500 prior to 2015, they would not be eligible to make a tax credit claim in 2015.

A taxpayer is not required to attach this certification statement to the return on which the credit is claimed. Income tax regulations require taxpayers maintain records sufficient to establish the entitlement to any credit claimed.
